**STANDARD OF PERFECTION**

To be banded in black and orange, as clearly defined as possible. is not to be considered a fault if bands are broken at the ventral or dorsal line. Points 10  
Belly and tail color may be light.

Seniors—Buck and Does 6 months of age and over, weight 6 to 8 pounds (2.7-3.6 kg).  
Juniors—Bucks and Does under 6 months of age.

**HAVANA**  
Varieties: Blue, Chocolate

**BODY TYPE**—Body should be cobby, rather compact, with full meaty shoulders, tapering from slightly broader and higher haunches.

**Weight and Condition**—Ideal weight: Senior Bucks and Does 6 pounds (2.7 kg). Registration weight: Senior Bucks and Does 5 to 7 pounds (2.3-3.2 kg). Solid and firm in flesh condition. Points 35

**Faults**—Long body, high rounded hips, dewlap.

**Disqualifications**—Excessive dewlap.

**RABBITS AND CAVIES**

**FUR**—To be soft, dense and lustrous, of medium length. Guard hairs slightly coarser in texture than under coat. With lots of sheen and lustre. Strive for same length of coat over entire body. Points 20

**Faults**—Long or silky texture fur, lacking density. White hairs in coat.

**Disqualifications**—Patches of foreign color hair.

**COLOR—Blue:** A medium dark blue, surface color very glossy and carried deep toward skin. Under color near skin to be dove color. Points 25

**Faults**—Faded light color. Cut severely for a noticeable brownish tinge in blue.

**Chocolate:** A very dark, glossy chocolate brown, so dark as to be the color of bitter-sweet chocolate when cut with a hot sharp knife. Surface color to be carried deep toward skin. Under color near skin to be dove color. Points 25

**Faults**—Faded light color.

**HEAD**—To be medium short and broad, with full cheeks. Broader in Bucks than in Does. Short neck having appearance of head being joined directly to shoulders. Points 5

**Faults**—Long neck or head.

**EARS**—To be in proportion to size of head and body, firm at base, carried erect and close together. Same color as body. Points 5

**EYES**—Medium size, having a soft, gentle expression. Points 4

Blue-gray in color for Blues.  
Brown, showing a red color in pupil in subdued light, for Chocolates.

**FEET AND LEGS**—To be straight and medium fine bone, rather short in length. Toe nails to be dark in color. Points 5

**Faults**—Long legs.

**TAIL**—Medium size, same color as body. Points 1
